# American Cancer Society Welcomes Five New Members and Newly-Elected Officers to Board of Directors

In addition, the new key officer leadership positions were announced which include, Scarlott K. Mueller, MPH, RN, as new Chair of the Board, Gainesville, Florida; Arnold M. The American Cancer Society Board of Directors consists of 21 members, which includes five officers and 16 directors. Directors are elected for a two-year term, and officers hold their position for a one-year term. The Board is responsible for setting policy, establishing long-term goals, monitoring general operations, and approving the organizational outcomes and allocation of resources.

Daniel Armstrong, PhD:** Armstrong is a Professor of Pediatrics and Psychology at the University of Miami Miller School of Medicine, with multiple leadership roles related to child health at the University of Miami and the Holtz Children's Hospital and Women's Hospital Center at the UM/Jackson Memorial Medical Center. Armstrong represents the American Cancer Society on the Florida Biomedical Research Advisory Council (BRAC), where he has served as Chair since 2013. He is also actively involved in state and local issues and organizations related to developmental disability and chronic illness. Armstrong is an American Cancer Society Florida Division Board Member past-President and Chair and was awarded the St. George National Award in 2015.

**Chau Dang, MS:** Dang is an Associate Principal at Accenture Technology Labs in the Digital Experience Research and Development group. She also serves as Co-Chair of the Gates Millennium Scholars Alumni Association National Volunteer Initiative, where she leads the partnership with American Cancer Society. She is responsible for the strategy and implementation of that effort.

**Carmen E. Guerra, MD, MSCE, FACP:** Guerra is an Associate Professor of Medicine at the Perelman School of Medicine of the University of Pennsylvania, and Associate Chief of Staff and Associate Director of the Abramson Cancer Center. Guerra is a primary care physician trained in epidemiology and a cancer control researcher. Guerra has been actively involved with the American Cancer Society for more than a decade and is current President of the Board for the East Central Division of the American Cancer Society and recently chaired Pennsylvania's inaugural 80x 2018 colorectal cancer screening leadership summit. **Brian A. Marlow, CFA:** Marlow is the President of KeyBank's South Puget Sound Market in Washington State, and oversees its Commercial and Private Banking operations. He is an active member of his community and is a leadership volunteer with the American Cancer Society. Marlow is a Director on the Great West Division Board. He has also served on a number of national committees for American Cancer Society, most notably as Co-Chair of Relay For Life, Chair of the Investment Committee, and Member of the Finance Committee.

**Gregory L. Pemberton, Esq.:** Pemberton recently retired as an attorney who primarily concentrated in corporate representation of all types of health care providers and tax-exempt organizations. Pemberton's current service as a member of the American Bar Association's House of Delegates allows him to advocate health care policy to the group that establishes national priorities for the association. He is actively involved with the American Cancer Society and is a member of multiple committees including, member of the Board for the Lakeshore Division of the American Cancer Society, a member of the Governance Committee, and member of the Nationwide Leadership Summit Advisory Group. He was awarded an American Cancer Society St. George National Award.

**Scarlott K. Mueller, MPH, RN**: Mueller recently retired as the Vice President and Chief Nursing Officer at the North Florida Regional Medical Center. She has been an American Cancer Society volunteer for 35 years. She has served on the Florida Division Board for 19 years and was the President/Chair from 2004 until 2005. She was awarded an American Cancer Society St. George National Award in 2010 and the Florida Division Distinguished Service Award in 2013. Mueller has served for five years on the American Cancer Society Board of Directors.

Baskies, MD, FACS**: Baskies is a Medical Director at Virtua Health Systems in Southern New Jersey, where he specializes in surgical oncology and general surgery as a breast surgeon and surgical oncologist.
