In her current role, she leads a practice comprised of over 4,000 professionals serving public and private clients across all industry sectors on local, national, and global levels. Most recently she served as PwC's US Human Capital Leader and Vice Chair, Global Talent Leader, and as a member of the US Leadership team she transformed the way PwC attracts, develops and inspires talent.
